Respected Madam/ Sir,

As part of 'Azadi ka Amrit Mahotsav' to celebrate the achievements of the country and its people, the Ministry of Education and UGC has organized a "Launch of Online Workshop for Universities and Colleges on Intellectual Property Rights (IPR)" on 17th January, 2022 with the collaboration of DPIIT & Controller General of Patents, Designs and Trade Marks (CGPDTM).

The Controller General of Patents, Designs and Trade Marks (CGPDTM), Department for Promotion of Industry and Internal trade, Ministry of Commerce and Industry, Government of India has launched a "National Intellectual property Awareness Mission (NIPAM)" with an aim to impart IPR Awareness/Training to 1 million students before 15th August, 2022 and to create a pool of Master Trainers (MTs) of IPRs for better cascading effect.

The office of the CGPDTM will provide resource persons for the IPR awareness programme and conduct separate training session for the identified MTs. In this connection all the participants, coordinators and also the MTs will be conferred upon certificate by the office or the CGPDTM upon offline/online participation in awareness/training programme under the NIPAM.

Vice Chancellors of Universities and Principals of Colleges are requested to organize a IPR awareness/ training programme under the said mission and nominate one faculty member from their institution to be trained as Master Trainer in IPR. The Universities and Colleges may send their request for organizing awareness programme under NIPAM, at nipam-mumbai@gov.in, nipam-delhi@gov.in, nipam-chennai@gov.in, nipam-kolkata@gov.in and/or may also connect to the respective nodal point as per list attached.

Rajiv Gandhi National Institute for Intellectual Property Management (RGNIIPM) has been established by the Government of India as the Center of Excellence for IPR training under the Ministry of Commerce & Industry and is engaged in conducting training programmes relating to Intellectual Property Rights (IPRs) i.e. Patents, Designs, Trademarks, GI & Copyrights, SICLDR, etc. **At present, the filing of Indian IP applications/Patents/Designs by Institutes, Universities are low despite their significant contribution towards R&D; like patent applications filed by the Indian Institutes/ students are very less as compared to foreign applicants.** Also, it was often observed that many inventors are losing the chance of obtaining Patents, Designs for their inventions by commercially using or publishing their inventions, designs in newspapers or scientific and technical journals, and such inventions are thus remained unprotected and may lose their exclusive rights.

As part of Azadi ka Amrit Mahotsav, the Government has decided to create awareness to 10 lakh students on IPR to further strengthen the IPR regime of our country which will boost the "Creative India, Innovative India" objective of the National IPR policy. Such initiative of outreach and promotion of IPR awareness is one of the foremost objectives of the National IPR policy which will stimulate the generation of IPRs. Therefore, in order to implement the objectives of National IPR Policy 2016, under the **National Intellectual Property Awareness Mission (NIPAM)** and to safeguard the interest of the inventors by upgrading IP skills of Faculties, Students, RGNIIPM has decided to conduct a "**Free Online workshop on IPR- Patents & Designs filing (with a certificate to all attended participants)**" for Educational Institutions students in order to protect their inventions in association with your organization.

Details of Program are as under:-

Topic- Intellectual property rights (IPR) & Patents, Designs filing (online program)

Duration- of the said online workshop will be around one hour

Organizer- RGNIIPM & your organization can jointly organize (Joint free online program)
