Kind attention is invited to the reference 1st cited wherein Government has issued orders directing all educational Institutions in Telangana to open in physical mode from 1st September, 2021 duly following covid norms.

2. Vide references 2nd and 3rd cited above, Advocate General of Telangana has informed about the directions of Hon'ble High Court of Telangana issued regarding opening of schools in W.P (PIL) no 98 of 2021.

3. Accordingly following clarifications are issued

1. All schools other than Government Residential School, Social Welfare Schools and Tribal welfare Schools with hostel facilities are permitted to open from 1st September, 2021
2. No child shall be compelled by any school management to physically attend offline classes, if his or her parent is not inclined to send the child to school
3. It is left open to school management to have either only offline or only online or both offline and online classes
4. Any undertaking obtained from parents by any school management absolving the school management of any liability if the child gets infected with virus while in school shall not have any legal effect.
5. Director School education is directed to lay down the SOPs to be followed by all school managements conducting classes offline within one week and give them wide publicity in print and electronic media.
