Item No. 01/17 To consider and ratify the action taken by the University for NIRF ranking 2025 in the category of Engineering.

The data was collected from all the Directorates, the Finance Department, and the Constituent Colleges, and subsequently consolidated in the formats prescribed by NIRF. The final dataset was submitted through the NIRF Portal (Data Capturing System) in December 2024. The data submitted for the NIRF Ranking under the Engineering category is provided in Annexure – I.

Resolution: Upon deliberations the committee members have resolved that, the data submitted by the university for the NIRF ranking 2025 in the category of Engineering be accepted and considered final. The action taken by the University in preparing and submitting the data be ratified and commended. The submitted data be used for all further communications, references, and evaluation processes associated with NIRF 2025.

Item No. 02/17 To consider and ratify the action taken by the University for NIRF ranking 2025 in the newly applied categories of SDG Institutions, Overall University and State Public University ranking.

The data has been submitted by the University for NIRF ranking 2025 in the newly applied categories of SDG Institutions, Overall University and State Public University ranking during the month of December, 2024. Earlier the university used to submit the data for NIRF Ranking in the category of engineering only.

The data submitted in NAAC portal is attached in Annexure – VI.

Resolution: The Committee recommends ratification of the action taken by the University for the submission of the Annual Quality Assurance Report (AQAR) to the National Assessment and Accreditation Council (NAAC) for the Academic Year 2023–24. The committee appreciates this as an essential step towards maintaining and enhancing the university's quality standards and compliance with accreditation requirements.

Item No. 08/17 To consider and ratify 10 parameters (out of 49 parameters given by UGC) are related to the curriculum and syllabus to be incorporated in the upcoming R25 regulations, in accordance with UGC guidelines.

UGC issued a draft Circular dated 3rd January, 2025 for granting privileges and entitlements under various UGC Regulations as per the National Education Policy (NEP)-2020. The UGC has given 49 parameters; under this 10 parameters are related to the curriculum and syllabus.

The following are the 10 parameters (Sl.No: 23, 24, 30, 31, 39, 42, 44, 45, 46 and 47) that may need to be incorporate in the upcoming R25 Regulations. The letter has been issued by the Registrar to the Directorate of Academic Affairs (DAAF) to incorporate the above parameters in the R25 regulations of the University.

Resolution: After deliberations the committee members have unanimously and ratified 10 parameters related to the curriculum and syllabus to be incorporated in the upcoming R25 regulations, in accordance with UGC guidelines.
