The functionality of the online portal for student services has been enhanced to allow candidates residing in foreign countries to apply for transcripts/certificates and have them delivered to their doorsteps through a courier service. This service has also been extended to sending students' testimonials to WES in Canada and the USA.

The Examination Branch has played a significant role in receiving University orders to conduct computer-based tests (CBT) for improving internal marks. The present Examination system aims at guiding the effective, efficient and lawful conduct of University examinations comprising, Under Graduate (UG) and Post Graduate (PG) programmes and Doctor of Philosophy (Ph.D.) programme. It also defines the roles, responsibilities of the people involved, protocols, procedures to be followed and various steps that have to be taken at all the levels associated with the conduct of the examinations under JAWAHARLAL NEHRU TECHNOLOGICAL UNIVERSITY HYDERABAD. All the Forms/Proforma for use in the examination process/ system and documentation have been drawn out in standardized formats. Measures to curb unfair and malpractices have also been listed along with the penalty and punishments.

Allotment of Exam Centers for students:

Students are jumbled cluster wise and mapped to host colleges for writing University Semester End Examinations without an undue advantage. Cluster based Jumbling Process is done with automation using In-house developed Software. In this Academic Year, 348931 students appeared for UG Examinations in 480 host centers monitored by approximately 500 observers from cluster colleges and more than 130 special observers from University. In this Academic Year, 22121students appeared for PG Examinations in 439 host centers monitored by approximately 450 observers from cluster colleges and more than 135 special observers from University.

3.4 Question Papers:

Examination branch conducted exam for various courses

UG – B.Tech/ B.Pharm / MoU Courses / BBA - 6182 PG – M.Tech/ MCA/ MBA/M.Pharm/ Pharm.D/ Pharm.D(PB) - 4952 Pre. Ph.D - 687

For all the above courses approximately 11,821 question papers were obtained from premier institution faculty members and the question papers are moderated by university subject experts.

After the results declaration within one week students can apply through online for re-counting or revaluation if the student is not satisfied with the acquired results. Around 32% of total students applied for RC/RV and grade change is less than one percent for this academic year

3.6. CHALLENGE VALUATION -

To improve transparency in the valuation process, CHALLENGE VALUATION has been introduced.

After the re-valuation, if the student is not satisfied with the marks awarded, the examination branch has given the opportunity to the student to apply for **CV**. In this process, examiner appointed by Controller of Examinations and student Parent College appointed faculty will participate in the challenge valuation in CE office. Initially they do independent valuation and then the discussion will follow to finalize the marks to be awarded. Student will also be allowed to go through the script and awarded marks and seeks clarification from evaluators regarding marks being awarded. A file compiled with challenge valuation awarded marks are submitted for approval before publishing of the result.

This academic year 0.02% have applied for challenge valuation where teacher of the student and university faculty member evaluated the answer script in the presence of the student.

4.0 Student Services

After the completion of the course, the students are scattered all over the world for different purposes, JNTUH Exam branch upgrades itself to meet the requirements of the students and also issue the certificates through online/offline services which will reach the students through by post or by hand within short time.
