Sir/Madam,

Vide ref (1) cited above, Principals are hereby informed to submit proposals for any Substitute/Equivalent Subjects for re-admitted students within two weeks of commencement of classwork of every semester. It has been observed that despite repeated instructions, some colleges are submitting proposals for substitute/equivalent subjects after the lapse of first two weeks and in some cases just before semester examinations, leading to unnecessary administrative delays. Hence, it is once again reiterated that proposals submitted beyond two weeks from commencement of classwork will attract a fine of Rs10,000/- per student for late submission.

Further, vide ref (2) with regard to transferred students, the equivalency of the syllabus of each subject already studied by the student must be verified in addition identification of additional subjects that need to be studied (if any) and clearanceletters must be obtained to from the University.

To complete this process, colleges must submit the syllabus copy of the previous institute/college for each subject and the proposed equivalent subjects at the current college. After thorough verification by the concerned Board of Studies (BOS) Chairpersons, equivalency will be established and clearance letters will be issued.

The following verification fee must be paid by the college for each transferred student, this fee is based on the year in which the student seeks admission.

Year Verification	Amount to be Paid per Student
I Year to II Year	Rs.10,000/- (one year subjects)
II Year to III Year	Rs.15,000/- (two years subjects)
III Year to IV Year	Rs.20,000/- (three years subjects)

As soon as the Commissionerate of Technical Education issues order, the host college is expected to approach this office for University orders with equivalent subjects.

Vide ref (3) cited above, Principals of autonomous and non-autonomous affiliated colleges are requested to go through the guidelines mentioned in the circular attached to the letter for offering Minors and Honours in B.Tech. The new minors for which approval was not taken earlier, permission should be taken within one month from commencement of classwork. It is reiterated that new proposals submitted after one month from commencement of classwork will attract a fine. Please note that there is no need for re-submission of proposals for which approval was taken in the previous academic years. Permission is required only for new minor courses which the college is planning to start in the current academic year 2025-26.

All Principals are instructed to ensure strict compliance with these guidelines to facilitate timely academic processing and smooth conduct of examinations

The students are transferred every year from various Engineering Colleges and Universities (including JNTUH Affiliated Autonomous Colleges / Affiliated Colleges) to JNTUH Affiliated Autonomous Colleges / Non-Autonomous Colleges of JNTUH, based on the GO's of the Govt. of Telangana/ Proceedings of the Commissioner of Technical Education, Govt. of Telangana.

The syllabus of the both institutions i.e., the syllabus of earlier institute/college where the student studied and the syllabus of the present institute/college which is to be studied, have to be communicated to the BOS Chairpersons concerned. It is involved lot of work to verify the syllabus of each and every subject and establish equivalency of subjects by the concerned BOS Chairpersons for each student. After verification of syllabus and based on the students' memos submitted by the college, clearance letters are issued to the Colleges mentioning the fail / pass subjects with credits, not studied/ not equivalent subjects and to be studied subjects for each student.

Hence, the following amount is to be collected from the Affiliated/Affiliated Autonomous Colleges for verifying the syllabus of each and every subject and establish equivalency of subjects by the concerned BOS Chairpersons for transferred students from various Engineering Colleges and Universities (including JNTUH Affiliated Autonomous Colleges / Affiliated Colleges) to JNTUH Affiliated Autonomous Colleges / None-Autonomous Colleges of JNTUH:
