- 7) The Supplier should be able to process the Order immediately without any delay, not exceeding 3 weeks. T e no advance payment by the University.
- 8) In case of foreign publications, Bank conversion rate / latest GOC (whichever is less) will be applicable on the voice. Proof for the exchange rate charged must be enclosed with the bill.
- 9) If there is any discrepancy or inability to process our orders on time, the same should be intimated immedi-University Librarian.
- 10) If the publication of the Journal is behind the schedule, the same should be informed accordingly along witted date of availability.
- 11) The Online journals which are available free along with print subscription should be provided by the Agent without charging any additional service charges.
