Terms and Conditions for Supply of Foreign and Indian Print Journals:

- 1) The Subscription Agent/Supplier shall be in existence for at least 05 years. Registration Certificate must be as a Proof.
- 2) The Supplier should have an office/representative preferably at Hyderabad.
- 3) The Subscription Agent must have a supply record to leading academic, education/research Universities/Or Colleges. In the past 3 years atleast 75% of the estimated value.
- 4) All print journals are to be supplied for the calendar year Jan 2024 - Dec 2024.
- 5) The price has to be offered for all the journals listed. If any of journal has been stopped/ceased by the publisher proof to be enclosed.
- 6) Certified copy of PAN and GST certificate to be enclosed.
- 7) The Supplier should be able to process the Order immediately without any delay, not exceeding 3 weeks. There is no advance payment by the University.
- 8) In case of foreign publications, Bank conversion rate / latest GOC (whichever is less) will be applicable on the invoice. Proof for the exchange rate charged must be enclosed with the bill.
- 9) If there is any discrepancy or inability to process our orders on time, the same should be intimated immediately to the University Librarian.
- 10) If the publication of the Journal is behind the schedule, the same should be informed accordingly along with the expected date of availability.
- 11) The Online journals which are available free along with print subscription should be provided by the Agent without charging any additional service charges.
- 12) No handling / service charges will be paid to the supplier.
- 13) The Supplier's representative shall visit the University Library to reconcile supply status at least once in a month.
- 14) DELIVERY OF PRINT JOURNALS:
 - (a) In order to avoid loss in transit all journals should be delivered by hand at regular intervals according to the frequency of journals.
 - (b) Vendor is required to inform the schedule of publication of each issue while accepting the order.
 - (c) Every publication should be supplied within a fortnight (15 days) of its publication scheduled. For any delay, a written proof showing the cause of the delay will have to be produced for consideration and taking appropriate action.
 - (d) Wrongly supplied or defective journals will be returned at the cost of supplier/s.
- 15) STATUS REPORTS: At the end of every month the vendor will submit a status report giving the details of the journals supplied during the month along with action taken on the pending supplies. In case of non supply, the subscription amount paid towards the same should be refunded without fail. The supplier shall monitor claims for missing issues and arrange to provide replacements.
